

LOTTERY QUESTIONS & ANSWERS

Question: Can I give a Lottery share to a friend as a Xmas present?

Answer : Yes, however the share will always be in the member's name. A share card will be issued detailing share numbers & distribution.

Question: How many shares can I buy?

Answer : As many as you like. The more shares you own, the greater your odds of winning

Question: As a parent of a junior member, am I allowed to have a Lottery share?

Answer : The share will be issued under the name of the member, be it he or she who is the member.

Question: Why don't we sell the Lottery to the public?

Answer : Our Lottery is private. Under the Lottery Regulations, we are not allowed to openly sell shares to the general public.

Question: Do we pay V. A. T. on Lottery contributions?

Answer : No. A private Lottery is exempt from V. A. T.

Question: Does the club need the money?

Answer : Yes. We can only maintain, develop & improve our facilities with money. The club's main source of income is Subscription charges and a combination of these charges & fund raising ventures are necessary for continued development.

LOTTERY RULES

1. The Lottery will be restricted to Senior, Intermediate, Junior and Non Playing members of the club.
2. The Lottery will consist of shares each having a value of £10.
3. Members may purchase as many shares as they wish. A share card will be issued.
4. The Lottery will consist of 11 monthly draws and a Xmas draw. The draw will take place on or around the 20th of each month, under the supervision of the Lottery organiser.
5. Membership of the Lottery is for the 12 month period commencing on 1st January each year.
6. No new members can be admitted to the lottery after the closing date.
7. No share card can be issued until payment for the shares has been received.
8. The winning names & numbers will be published and displayed on the club notice board after the draw has taken place.
9. Monies will be allocated on the following basis, 50% in prize money and 50% to club funds.
10. A financial statement will be published with the Annual Accounts each year.
11. The Executive Committee's decision regarding the Lottery will be binding and final.
12. The rules of the Lottery will hold for one year and will be subject to review as and when required.
